

PAY ATTENTION: IMPORTANT WARNING TO ALL CREWS **ABOUT EVENT REGISTRATION !!!**

THIS YEAR, ENTRIES METHOD CHANGED: THEY WILL BE ONLINE AND DIVERSIFIED FOR THE INTERNATIONAL FIA RACE (EHRSC) AND NATIONAL ACI SPORT RACE (CIRAS). AFTER COMPLETING THE MANDATORILY ENTRIES APPLICATION ON- LINE, HOWEVER IT'S REQUIRED TO SEND BY EMAIL acilivornosport@acilivorno.it THE ENTRY FORM DOWNLOADABLE ON WEB SITE FILLED IN EVERY PART.

REGISTRATION TO THE INTERNATIONAL RALLY VALID FOR THE FIA CHAMPIONSHIP (EHRSC)

a) registered drivers in the EHRSC championship must fill in the online form available at the following link: <https://registrations.fia.com/EHSRC>

b) not registered drivers in the championship, who want to participate in the FIA international competition (without collecting points) must use another online form available at the following link: https://registrations.fia.com/EHSRC_8ITA

The form must be correctly filled in and sent to the organizer before registration closure. Note that the registration platform on the FIA website requires the use of credentials (User ID and password) for access. Please do not wait until the last moment to create the account and enter the registration so as not to exceed the closing date of the registration.

REGISTRATION ONLY FOR THE NATIONAL RALLY (VALID FOR CIRAS)

A. The Competitor/driver owner of an ITALIAN LICENSE (issued by the ACI SPORT Federation), by accessing the reserved area of the federation website www.acisport.it, can pre-register in the race, checking that his personal data, the indications and the deadlines relating to the driving license, the Acì card and the medical certificate are correct.

Access the "area riservata" (Reserved area) of the website www.acisport.it using the credentials and the license valid for the current year, select "gare e calendari" (Races and calendars), choose the race to which you wish to register and proceed with entering all the requested data.

Once the data entry phase is complete, the pre-registration will be viewed by the organizer who, within the same program, will transform it into a definitive registration.

B. The Competitor/driver owner of a FOREIGN LICENSE must download the application form from the organizer's website, fill them in properly and send them by email (acilivornosport@acilivorno.it) together with the following documents:

- Valid License
- Medical fiche,
- ASN authorization
- Identity card
- Driving license
- copy of the bank transfer certifying the payment of the registration fee
- standard car declaration for reconnaissance (see form n.3)

PLEASE NOTE: Those who own HTP FIA and int C / R license, even if not registered in the European Championship EHRSC, could register in the international race (without taking points), following the registration procedure for the international race (of course they will have to omit to register on the online platform ACI SPORT).

SPORTS CHECK PROCEDURE

Since the administrative checks will be carried out by remote procedure, all competitors must send via email (acilivornosport@acilivorno.it), if they have not already uploaded them on the FIA platform during the registration procedure, the following documents, still valid:

- Competitor's license
- Driver's licenses for driver and co-driver
- Driver's and co-driver's driving license
- Driver's and co-driver's photo
- Driver's and co-driver's document
- ASN authorization (mandatory for all foreign competitors and/or drivers)
- Completion of all the details in the registration form
- Medical certificate or personal accident insurance valid for drivers from outside the EU
- Vehicle registration document, when applicable
- 1st valid HTP FIA or ACI SPORT page of the car
- copy of the bank transfer certifying the payment of the registration fee
- standard car declaration for reconnaissance (see form n.3)

PROCEDURE FOR TECHNICAL CHECKS

Concerning Scrutinering, Competitors must fill in and deliver directly to the Organizer by email acilivornosport@acilivorno.it the following documents downloadable below link (english forms) :

ACCREDITATION PROCEDURE

By the closing date of the entries **each competitor must send to the organizer the complete list of his staff, indicating the name of the contact person and the other sports operators: crew, mechanics, manager ... (see team list mod.6 _ mod.8)**

Each car participating in a race will have a maximum of pass (bracelets) as shown below:

- Car registered by a Competitor legal person.: nr. 8 sports operators
- Car registered by a Competitor physical person.: nr. 6 sports operators

METHODS FOR THE WITHDRAWAL OF THE ROAD BOOK

A self-certification of possession of the driving license and anti-Covid declaration for each registered driver, must be presented at the time of collection of the road book by the contact person of the Competitor. (see form available on the website self declaration driving license _mandatory mod.1 and anti – Covid declaration mod.2).

INVOICING and REQUEST OF THE SERVICE PARK AREA

For the electronic invoicing concerning the payment of the registration fee, please fill in the form available on the competition website with all the required data (company name, name and surname, IP and/or tax code, unique code and/or PEC address) and send it to the following e-mail address: acilivornosport@acilivorno.it accompanied by a copy of the bank transfer certifying the payment of the registration fee, as well as the data sheet for requesting the Service Park work area (see entry form).
